Please note! This letter contains important Information about your waste containers

Subject: You will soon receive new mini-containers

Dear resident.

The Municipality of Dronten is going to exchange the mini-containers for Vegetable, Fruit and Garden Waste (GFT), paper and Plastic Cans and Drinks Packaging (PBD). This means that we will collect your current containers and you will receive new mini-containers in return. This letter explains what you need to do and how you can change the size of your new mini-container(s) if necessary.

The containers are fitted with a microchip

All new mini-containers for household waste in the Municipality of Dronten will be fitted with a microchip. The chip contains a unique number that is registered with your address. We are doing this to provide a better service, to combat illegal containers and to better manage the stock levels. It also enables us to provide targeted information about separating waste. You will find information about the Privacy Regulations regarding Microchips and the Waste Card (Afvalpas) at the website www.dronten.nl/direct-regelen/afval/omwisselen-minicontainers. It states there what data we record and for what reason.

What are we going to do exactly?

- We will be exchanging all old mini-containers for new ones in the Municipality of Dronten. These will have a capacity of 240 litres. You will receive a maximum of one container for each type of waste, with the exception of paper, for which you will receive a maximum of two;
- You can request a different format of mini-container once free of charge. If you do this before 23 September 2022, this is free of charge. After this date, you can only request another size of container after 1 January 2023, and the exchange of a mini-container will cost € 40 per container each time;
- Your choice of a smaller or larger container **does not** affect the annual waste collection charge.

If you don't respond to this letter, then you will receive the following mini containers:

- One residual waste container of 240 litres
- Two paper containers of 240 litres
- One GFT container of 240 litres
- One PBD container of 240 litres

Smaller containers?

Would you prefer to receive a smaller **180 litre** mini-container for one or more types of waste? Please let us know **before 23 September 2022** via www.containerkeuzedronten.nl.

Between 8 and 23 September, sample containers will be available at various locations in all village centres.

When will the mini-containers be exchanged and emptied?

We will be exchanging the mini-containers between October and December 2022. You will receive a letter before the containers are exchanged in your neighbourhood. This letter will explain how the exchange works and when we will visit your address. You do not have to stay at home for the exchange process. The usual collection days for your waste collection will not change.
